# 3. How to get reimbursed for your at-home test kit that you bought at the pharmacy

- Starting January 15, most people with a health plan can go online, or to a pharmacy or store to purchase an at-home over-the-counter COVID-19 diagnostic test authorized by the U.S. Food and Drug Administration (FDA) at no cost, either through reimbursement or free of charge through their insurance.
- Be sure to keep your receipt if you need to submit a claim to your insurance company for reimbursement. Insurance companies are required to reimburse you at a rate of up to \$12 per individual test (or the cost of the test, if less than \$12).

#### 4. Update from the CDC

- COVID-19 <u>cases</u> and <u>hospitalizations</u> are starting to decline across the United States. However, <u>deaths</u> are still rising, and <u>community transmission</u> is still high nationwide.
- Two new CDC reports show that people who are up to date with their COVID-19 vaccines have the highest amount of protection against both the <u>Delta</u> and <u>Omicron</u> variants.<sup>1,2</sup> One <u>report</u> found that, compared to up-to-date adults, unvaccinated adults had five times the risk of infection and more than 50 times the risk of COVID-19-associated death. A second <u>report</u> found that a third dose (either an additional primary dose or booster dose) of an <u>mRNA COVID-19 vaccine</u> (Pfizer-BioNTech or Moderna) was highly effective at preventing emergency and urgent care visits and hospitalizations related to COVID-19.
- COVID Data Tracker's Hospitalizations by <u>Vaccination Status COVID-NET</u> tab features
  more new data showing the effectiveness of vaccines and boosters. In December 2021,
  for example, unvaccinated adults ages 65 years and older were 49 times more likely to
  be hospitalized for COVID-19 than people in that age group who were up to date with
  their COVID-19 vaccines.


